FINAL JUDGMENT AVOIDING LIENS OF CONDOR AERIAL, LLC

This cause came before the Court on the Adversary Complaint (Doc. 1) filed by Plaintiff Theresa M. Bender, Chapter 7 Trustee, seeking the avoidance of any and all liens in favor of Condor Aerial, LLC as preferential transfers pursuant to 11 U.S.C. §547 in the above-captioned adversary proceeding and the parties' subsequent Joint Stipulation for Entry of Final Judgment of Avoiding the Liens of Condor Aerial, LLC (Doc. 6). Having considered the stipulation of the parties and otherwise being fully advised in the premises, it is

ORDERED and ADJUDGED:

1. Judgment is entered in favor Plaintiff Theresa M. Bender, Chapter 7
Trustee, on Count I of the Adversary Complaint (Doc. 1).

2. Pursuant to 11 U.S.C. §547, any and all liens in favor of Condor Aerial, LLC ("Condor") on the Debtor's property are avoided including any lien(s) created by (1) the recordation of a certified copy of Condor's state court judgment against the Debtor dated October 3, 2017 (the "First Judgment"); (2) the filing of a electronic judgment lien certificate with the Florida Secretary of State regarding the First Judgment dated October 3, 2017; (3) the recordation of a certified copy of Condor's state court judgment against the Debtor dated January 10, 2018 (the "Second Judgment"); and (4) the filing of a electronic judgment lien certificate with the Florida Secretary of State regarding the Second Judgment dated October 3, 2017.

- 3. This Judgment shall not affect Condor Aerial, LLC's ability to assert its full unsecured claim.
 - 4. The parties shall bear their own attorney's fees and costs.
