4. In the event Defendant defaults in payments, Plaintiff shall be entitled to declare the sum

of \$1,700.00, immediately due and payable.

5. Defendant acknowledges and stipulates that if Defendant fails to make any payment as

agreed, the remaining \$1,700.00, less any payments made, shall be immediately due and

payable.

6. Plaintiff will refrain from pursuing its rights under this agreement so long as Defendant

continues to make payment on a regular, timely basis. If Defendant defaults, however,

Plaintiff shall have the right to pursue any legally available remedy without further

notice, and without need for further relief from the automatic stay in any bankruptcy

proceeding in which the Defendant is a Debtor pursuant to 11 U.S.C. § 362(c)(2)(C).

7. The parties shall pay their own attorney fees and costs in this matter.
