THIS CAUSE having come before the Court on the Motion for Default by Rapid Management Company, Debtor in Possession, and no timely response pleading by the Defendants having been filed, it is hereby

ORDERED AND ADJUDGED

1. The Plaintiff, Rapid Management Company, shall recover from the Defendants jointly and severally the sum of calculated as \$150 per day per container (38) from the date of the filing of the Chapter 11 Petition (12/18/02) until the date of the signing of this order or a total sum of \$27,300.00.
2. The Defendants are ordered to turn over the containers as set forth in exhibit A attached to this order, by June 26, 2003, by delivery of "empty" containers to the site of Rapid Management Company located at Clark Site & Sand, 131 Navy Blvd., Pensacola, Florida. For each container not delivered by the date set forth in this

order, Rapid Management Company shall be awarded the sum of \$1,600 per container as additional damages.

3. Rapid Management Company is directed to file an affidavit setting forth which containers in exhibit A attached to this order were delivered timely, and setting forth the number of containers subject to this order which were not delivered by the Defendants by the time set by this Court.
