**ORDER AND JUDGMENT**

GE Commercial Distribution Finance Corp. ("GE") filed a Motion for Summary Judgment on October 21, 2009, against Bank of the West and defendants Leisure Tyme, RV. Inc., Gayle Hill, Brian Hill, Bruce E. Davis, and Gregory A. Davis. Bank of the West responded to the Motion for Summary Judgment on November 3, 2009. No other defendants responded. This Court held a hearing as to the claims between GE and Bank of the West on November 30, 2009. On December 30, 2009, this Court entered an Order denying GE's claims against Bank of the West and Granting Bank of the West's Motion for Summary Judgment on claims asserted by GE against Bank of the West. The Court did not address GE's claims against the other defendants in that Order.

Pursuant to Local Rule 9013-1, and in accordance with this Court's opinion in its Order Denying GE's Motion to Reconsider, summary judgment against the parties who did not respond to GE's Motion for Summary Judgment is appropriate. Therefore it is ORDERED that GE's Motion for Summary Judgment against Leisure Tyme, RV, Inc., Gayle Hill, Brian Hill, Bruce E. Davis, and Gregory A. Davis is due to be GRANTED.

It is ORDERED that:

- 1) The Court awards judgment in favor of Bank of the West against GE Commercial Distribution Finance Corp.
- 2) The Court awards judgment in favor of GE Commercial Distribution Finance Corp. against Leisure Tyme, RV, Inc., Gayle Hill, Brian Hill, Bruce E. Davis, and Gregory A. Davis.
