THIS MATTER having come on to be heard on the Joint Motion of all parties to this Adversary Proceeding and on Settlement Agreement, and the Court having considered same, it is

ORDERED AND ADJUDGED that Plaintiff, U. S. Acquisition, LLC, 3300 Parker Road, 5th Floor, Aurora, Colorado 80014, recover from Defendant, Larry D. Turley, the sum of \$1,123,381.96 in principal, \$36,912.00 for attorneys fees and \$660.25 for the costs, which sum totals \$1,160,704.21 as of the date of this Final Judgment, for a total Final Judgment amount owing of \$1,160,704.21, the total of which shall after the entry of this

judgment shall bear interest at the rate of 11% per annum from the date of entry hereof until paid, for which let execution issue. This debt is determined nondischargeable under 11 U.S.C. § 523(a)(2).

IT IS FURTHER ORDERED AND ADJUDGED, that Defendant Kathleen R. Turley is hereby dismissed from this adversary proceeding.
