**CONSENT FINAL JUDGMENT**

This matter is before the Court on a complaint by Mary W. Colón, Chapter 7 Trustee for avoidance of a transfer under 11 U.S.C. §547 and to sell personal property free and clear of the liens and interests of Defendant James A. Boyd, Sr. pursuant to 11 U.S.C. 363(h) and the Consent Motion to Enter Final Judgment (Doc. 13). Defendant James A. Boyd, Sr. filed an answer admitting the allegations of the Complaint. As to Defendant Boyd, a judgment on the pleadings was appropriate at that time. Further, all parties have reached an agreement that the relief requested should be granted and have consented to this final judgment. Accordingly, it is

**ORDERED**

Final Judgment is entered for Plaintiff, Mary W. Colón. As to Count I, the lien filed by Hancock Bank against the personal property of Debtor is avoided. As to Count II, Trustee is authorized to sell the personal property as further identified below free and clear of the interests of James A. Boyd, Sr. and Hancock Bank.

Trustee is authorized to sell the personal property identified in Exhibit "A" free and clear of all liens and interest to Nancy G. Boyd subject to expiration of a Notice of Intent to Sell being filed in the administrative case. Upon the sale, Hancock Bank shall be entitled to one half of the sale proceeds of all property identified in Exhibit "A". Trustee is authorized to pay to Hancock Bank one-half of the sale proceeds in the amount of \$38,322.57 upon receipt of funds.


Trustee is authorized to sell the personal property identified in Exhibit "B" free and clear of the liens and interest to Nancy G. Boyd subject to expiration of a Notice of Intent to Sell being filed in the administrative case. Trustee shall deposit all proceeds from the sale of this property into the estate account to be administered pursuant to further order of this Court.

Trustee is authorized to sell the personal property identified in Exhibit "C" to Nancy G. Boyd subject to expiration of a Notice of Intent to Sell being filed in the administrative case. The sale proceeds shall be disbursed as follows: to James A. Boyd, Sr. as to one-half of the proceeds, namely \$2,452.37; the remaining proceeds shall be deposited into the estate account to be administered pursuant to further order of this Court.

Trustee is authorized to take any and all actions and to execute any and all documents necessary and appropriate to effectuate and consummate the terms of

said sale of the property free and clear of all liens, encumbrances, or interests, including without limitation, executing a bill of sale conveying the interest of the Debtor and James A. Boyd, Sr., or any other party claiming an interest in the Property, to the current purchaser.
