



**SUMMARY FINAL JUDGMENT OF GARNISHMENT AGAINST GARNISHEE, SUNSHINE SAVINGS  
BANK**

This matter came before the court on Plaintiff, Simpler Solar Systems, Inc.'s, Alias Writ of Garnishment issued on June 19, 2014 (Doc. 171), served on Garnishee, Sunshine Savings Bank on June 20, 2014 (Doc. 174), answered by Garnishee, Sunshine Savings Bank on June 20, 2014 (Doc. 172), and the court having previously ruled that the unrefuted evidence showed that the funds transferred from Renitta Knight Construction, LLC's Bank of America account to the joint Sunshine Savings Bank savings account, to Lundy's Sunshine Savings Bank checking account were the "Sperry Money" (Doc. 128, p. 12), and being otherwise fully advised in the premises, enters Summary Final Judgment against Sunshine Savings Bank, pursuant to Florida Statute, section 77.083, as follows:

1. Judgment is entered against Garnishee, Sunshine Savings Bank in the amount of \$32,325.50.

2. Garnishee, Sunshine Savings Bank shall surrender the amount of \$32,325.50, to Plaintiff, Simpler Solar Systems, Inc., c/o Robert C. Bruner, Esq., 261 Pinewood Drive, Tallahassee, Florida 32303, within 15 days from the date of this Summary Final Judgment.

3. In the event that Garnishee, Sunshine Savings Bank does not timely surrender the funds referenced in paragraph 2 above, this court orders the issuance of execution to be against Garnishee, Sunshine Savings Bank pursuant to Florida Statute, section 77.13, for the unpaid amount of Plaintiff's Judgment against Defendant, Renitta Knight Construction, LLC.
