FINAL JUDGMENT AGAINST SOUTHWEST LABORATORIES, LLC

THIS MATTER came before the Court upon the Complaint of Marshall Glade, Liquidating Trustee of the Campbellton-Graceville Hospital Liquidating Trust (“Plaintiff”) against the Defendant Southwest Laboratories, LLC (the “Defendant”) to avoid and recover a fraudulent transfer, pursuant to 11 U.S.C. §§ 544, 548, and 550, in the amount of \$1,113,868.81. Defendant, having consented hereto pursuant to that certain Mediation Agreement (Main Case Doc. 1043) which was approved by the Court (Main Case Doc. 1059), and the Court, having entered the *Order Granting Liquidating Trustee’s Motion for Entry of Judgment Against*

Southwest Laboratories, LLC Pursuant to Mediation Agreement
(Doc. 12) [ECF No. 17], it is the judgment of the Court that:

1. Defendant, Southwest Laboratories, LLC, whose last known address is Southwest Laboratories, LLC, c/o Mccathern Law, 3710 Rawlins Street, Suite 1600, Dallas, Texas, 75219, hereby consents to the entry of a Final Judgment for the avoidance and recovery of fraudulent transfers in the above-referenced action in favor of Plaintiff in the amount of \$1,113,868.81.

2. Judgment is hereby entered in favor of the Plaintiff, Marshall Glade, Liquidating Trustee, and against the Defendant, Southwest Laboratories, LLC in the amount \$1,113,868.81.

3. Said Final Judgment shall bear interest at the maximum rate allowed by law. Execution on said Final Judgment shall immediately issue.
